Our focus. Your priorities.

This policing plan will outline the priorities your community identified during our most recent consultation. It will inform you of the action we have taken up until now to address those priorities and how we plan to continue to address them throughout the year.

Our focus is to reduce crime and disorder, to increase public reassurance within your community and to keep people safe.

We will continue to work closely with our partners and find effective long-term solutions to the issues you raised.

Local Priorities

You identified that the policing priorities for Strathmore area were:

1. Speeding and Inconsiderate Driving

You told us the area that concerned you most was speeding and inconsiderate driving and parking in your villages and trunk roads.

2. Antisocial Behaviour

You told us your concerns about people engaging in acts of antisocial behaviour including vandalism and littering.

3. Drugs

You told us your concerns about people dealing and abusing drugs in the community, along with the drugs paraphernalia left behind by those persons.

4. Housebreaking & Theft

You told us of the frustrations and upset caused, of having your property broken into, which was a concern.

We have acted on your concerns and are sure you will have seen improvements in the Strathmore area.

Our actions to date.

Speeding and Inconsiderate Driving

We have targeted specific roads identified by the local community and known risk areas. Officers patrol roads and school areas, utilising the speed detection tools available to identify and report offenders.

Antisocial Behaviour

Through Operation Quest we have focussed our officers to target antisocial and violent crime in the Strathmore area. By utilising public forums, such as community councils, pubwatch and schools, we identify those responsible.

Drugs

By collating intelligence and liaising with our partners we are able to identify persons responsible with possessing and distributing controlled drugs, allowing us to search persons and property, reporting those offenders to the Procurator Fiscal.

Housebreaking & Theft

Local and national operations assist with identifying those perpetrators involved with these types of crimes, and ensuring those persons are apprehended. Crime prevention advice encourages members of the public to assess their own property.

Speeding and Inconsiderate Driving

We will be working with our partners and Road Policing Unit to identify problem areas, sharing information, to make the roads safer. This will involve Speed Check locations, and policing around the schools.

Antisocial Behaviour

We will continue to be proactive in dealing with antisocial behaviour by ensuring we have a multi agency approach to provide the most effective service to our community.

Drugs

We will continue to gather and process intelligence received in relation to controlled drugs, by carrying out robust enforcement and activity.

Housebreaking & Theft

As the nights get darker we encourage householders to reassess their home security to make their property less attractive to criminals. Community Watch is a further tool we continue to utilise to ensure lines of communication are kept open between ourselves and the community.
