FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

Average speed cameras in Glasgow's Southside.

They were installed on Parkhouse Road, between Whitriggs Road and Nitshill Road, last year and activated on December 5, 2021.

Specifically, I would like the following information, from December 5, 2021, to December 5, 2022, please:

The number of fixed penalty notices issued – broken down by date and speed caught at (as long as this is within the cost limits, please)

The following information is provided in relation to vehicles detected speeding by the Safety Camera Unit and subsequently issued with a Conditional Offer of Fixed Penalty Notice and/ or a report was made to the Procurator Fiscal.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
