FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

I would like a summary of calls to police where the logs include the word 'paranormal activity' from January 2019 to date.

I must firstly advise you that whilst incidents are categorised, there is no specific category which relates to the type of incident referred to in your request.

As such, a keyword search of ""Paranormal"" and ""Paranormal Activity"" was carried out on the incident description and Comment 180 fields within the incidents recorded by call handlers on Police Scotland's incident recording system, STORM.

The table below provides the number of incidents recorded on STORM which mention 'Paranormal' or 'Paranormal Activity', between 1st January 2019 and 28th February 2022.

The data was extracted from the Storm Unity Database using the incident's raised date and all incident types have been included.

If possible I would like the information to be broken down on a month by month basis with a brief summary of the incident, and if possible any action taken. If the scope of this request is too broad please just provide a brief summary.

If you are dissatisfied with the way in which Police Scotland has dealt with your request, you are entitled, in the first instance, to request a review of our actions and decisions. Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to foi@scotland.police.uk or by post to Information Management (Disclosure), Police Scotland, Clyde Gateway, 2 French Street, Dalmarnock, G40 4EH.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
