FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

- 1. In the years 2017, 2018, 2019, 2020, 2021 – How many incidents of theft were recorded involving e-scooters?**
- 2. In the years 2017, 2018, 2019, 2020, 2021 – How many incidents of injury or serious injury were recorded involving e-scooters?**
- 3. In the years 2017, 2018, 2019, 2020, 2021 – How many incidents of deaths were recorded involving e-scooters?**
- 4. In the years 2017, 2018, 2019, 2020, 2021 – How many incidents were recorded where e-scooter use was mentioned involving organised or serious organised crime?**

Having considered your request in terms of the Act, I regret to inform you that I am unable to provide you with the information you have requested, as it would prove too costly to do so within the context of the fee regulations.

As you may be aware the current cost threshold is £600 and I estimate that it would cost well in excess of this amount to process your request.

As such, and in terms of Section 16(4) of the Freedom of Information (Scotland) Act 2002 where Section 12(1) of the Act (Excessive Cost of Compliance) has been applied, this represents a refusal notice for the information sought.

By way of explanation, none of the recording systems relevant to your questions have the facility whereby 'e-scooter related' can be searched. Therefore tens of thousands of reports would have to be manually examined. As such this is an exercise which I estimate would far exceed the cost limit set out in the Fees Regulations.

If you are dissatisfied with the way in which Police Scotland has dealt with your request, you are entitled, in the first instance, to request a review of our actions and decisions.

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
