#### FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

I am putting in a freedom of information request date 17/01/2022 to seek information around criminal complaint 6029679/21 in the public interest around vaccines and crime that have been committed against the British public.

# 1) On the 20th December 2021 a crime was reported to Hammersmith Police station ref 6029679/21, this made allegations of serious crimes against the British public. Can you conform that the Chief constable has been made aware of this investigation?

The Metropolitan Police Service received a complaint and a number of documents on 20 December 2021. The MPS provided the complainers with a crime reference number and is reviewing the content of the documents.

However, the MPS has been clear that nothing has been found to suggest any offences or grounds for an investigation, and that no such investigation is taking place. This has been communicated to all Chief Constables in the UK

### 2) Can you conform that the Chief Constable took action to inform all police officers under His/her command around this criminal investigation.

All officers are aware of the foregoing and that no such investigation is taking place.

## 3) Can you conform that your police force is actively taking criminal complaint around vaccines or covid related crimes made by the public and assigning crime reference number to support criminal investigations.

Police Scotland will assess all complaints made. To date no criminal activity has been identified and no crime reports raised.

4) Can you please conform how many crimes reference number have been allocated when reports are made by the public of crimes committed against them in relations to vaccines injuries or blackmail and coercion in relation to vaccines.

5) How many crimes reference numbers have been allocated for use of Midazolam and Remdesivir medication used as end of life treatment or as a treatment for covid 19.

## 6) Has any action been taken to stop the vaccine in your area to protect the British public from significant harm which can led to significant injuries up to and including death?

It is not for Police Scotland to comment on or interfere with the Scottish Government's health policy. As noted above, Police Scotland will assess all complaints made. To date no criminal activity has been identified and no crime reports raised.

#### 7) Reports online has made allegations that police have had a banned in place from Government not to give crime reference numbers in relations to Covid 19 or vaccine in this statement correct, if it is correct how sent request for this to be in place?

This is incorrect. Where a crime can be established a crime report will be raised. No such crime has been established from any information received.

### 8) Can you conform this investigation 6029679/21 in still active and being investigated?

This is not a Police Scotland crime or incident reference number and so we do not hold any further information other than noted above. As such, in terms of Section 17 of the Freedom of Information (Scotland) Act 2002, this represents a notice that the information requested is not held by Police Scotland.


