## **FREEDOM OF INFORMATION (SCOTLAND) ACT 2002**

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

Police Scotland aims to provide the best possible service to the people of Scotland however recognises that on occasion the service received falls short of the standards expected by the public and the police themselves.

In addition I have attached a link to the Police Scotland's Conduct Regulations - can I please draw your attention to Section 8 of these regulations, which outlines our Suspension Policy.

The questions have been slightly adjusted to reflect that officer and police staff data is recorded separately.

1. The total number of police officers currently suspended by Police Scotland, and suspended in 2020 and 2021.

The number of Police Officers currently suspended, as at 08/04/2022, has been provided in the table below. Also provided are the number of officers who were serving a suspension at any point within the 2021 calendar year, as well as any point within the 2020 calendar year.

Please note that the initial date of suspension may precede the specified periods below and suspensions may continue to be served beyond those same date periods. Suspension may also have been removed during the same period.

2. Please note, due to low numbers and to avoid those suspended being identified, we have provided the response to question 3 in grouped grades.

### 4. The total paid in salaries to suspended workers in 2021 and 2020.

#### 5. The total paid in other expenses to suspended workers in 2021 and 2020.

Q4 and Q5 have been answered together for ease of response.

In response, I regret to inform you that I am unable to provide you with the information you have requested, as it would prove too costly to do so within the context of the fee regulations.

As you may be aware the current cost threshold is £600 and I estimate that it would cost well in excess of this amount to process your request.

As such, and in terms of Section 16(4) of the Freedom of Information (Scotland) Act 2002 where Section 12(1) of the Act (Excessive Cost of Compliance) has been applied, this represents a refusal notice for the information sought.

To first explain, payments to suspended individuals are not specifically marked and would be calculated by payroll in the normal manner and paid directly. As there is no automated method of identifying the relevant expenditure, any undertaking to identify such payments would require us to interrogate our payroll system for details relating to every relevant officer and member of staff, in each of the time periods requested.

In summary, without a largely manual exercise we would have no way of answering this question, and this is true even across a much reduced timescale.

As the details requested are not held in a retrievable format identifying the requested information would take a significant period of time. Police Scotland have assessed that the £600 cost limit within the Act equates to 40 hours of work and so your request would breach the cost threshold.

#### 6. The total paid in pensions to suspended workers in 2021 and 2020.

I must advise you that Police Pensions IDRP is managed by the Scheme Manager, Scottish Police Pension Agency (SPPA). As such, in terms of Section 17 of the Freedom of Information (Scotland) Act 2002, this represents a notice that the information you seek is not held by Police Scotland.

If you require further assistance or are dissatisfied with the way in which Police Scotland has dealt with your request, you are entitled, in the first instance, to request a review of our actions and decisions.

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to foi@scotland.pnn.police.uk or by post to Information Management (Disclosure), Police Scotland, Clyde Gateway, 2 French Street, Dalmarnock, G40 4EH.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
