FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response for each question.

I require is public records of a certain traffic enforcement camera. The details for the location of the camera is Great Western Road, opposite Blairdardie primary school. Glasgow, G156HL. I will be requiring details of the cameras last 3 years calibration records covering 2020, 2021 and 2022. The calibration certificates should include:

The device manufacturer

The manufacturer is Gatso.

The name of the person certified to conduct the test

Date carried out

Statement of replaced parts

Calibration measurements

Include confirmation of secondary check to ensure this obeys the tolerance limits (maximum and minimum delay times.)

5 speed test results

Please include any and all relevant documents pertaining to the set up and/ or maintenance of the camera.

I can advise that Police Scotland does not hold the above requested information. In terms of Section 17 of the Act, this letter represents a formal notice that information is not held.

By way of explanation, the camera housings and the cameras are calibrated annually. The annual calibrations are undertaken by an outside company and we do not hold the paperwork for this.

I can advise you that Police Scotland does not hold information in the format requested. In terms of Section 17 of the Act, this letter represents a formal notice that information is not held.

By way of explanation, it is public knowledge that not all cameras will be live at any one time. Cameras are rotated and as such over a 3 year period numerous cameras will have been utilised at this site.

As you will be aware an individual's right in terms of the legislation is to obtain information held by a public authority at the time a request is received and there is no obligation on them to create new information specifically for a request. In this instance information is not held in the format requested and would be complex to provide.

If you wish to refine your request to a specific date then a calibration certificate and the operating frequency can be provided.

If you are dissatisfied with the way in which Police Scotland has dealt with your request, you are entitled, in the first instance, to request a review of our actions and decisions.

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to foi@scotland.pnn.police.uk or by post to Information Management (Disclosure), Police Scotland, Clyde Gateway, 2 French Street, Dalmarnock, G40 4EH.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
