FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

I would be grateful if you could provide the following information for the period 1st January 2019 to 31 July 2022, broken down by year-month and broad geographic region within Scotland:

- 1) The number of complaints received about CCTV relating to domestic properties.**
- 2) The number of reported incidents where CCTV relating to domestic properties has been a factor in the incident.**
- 3) The number of investigations in which footage or audio from CCTV relating to domestic properties formed part of the evidence of the investigation.**

Having considered your request in terms of the Act, I regret to inform you that I am unable to provide you with the information you have requested, as it would prove too costly to do so within the context of the fee regulations.

As you may be aware the current cost threshold is £600 and I estimate that it would cost well in excess of this amount to process your request.

As such, and in terms of Section 16(4) of the Freedom of Information (Scotland) Act 2002 where Section 12(1) of the Act (Excessive Cost of Compliance) has been applied, this represents a refusal notice for the information sought.

By way of explanation, there are no markers on our incident or crime recording systems which would allow for the retrieval of this information. Therefore all incidents and crimes would have to be examined to establish whether CCTV is mentioned and in what context. Given the tens of thousands of reports, this is an exercise which would far exceed the cost limit set out in the Fees Regulations.

If you are dissatisfied with the way in which Police Scotland has dealt with your request, you are entitled, in the first instance, to request a review of our actions and decisions.

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
