## FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

- **Can you tell me how many reports of thefts from shops involving food have been for each month since the start of 2021.**
- **Can you give me this information only for the Greater Glasgow and Edinburgh areas.**
- **I would also be interested in seeing any further details about the crimes, IE, circumstances of how they were carried out.**

Having considered this question in terms of the Act, I regret to inform you that I am unable to provide you with the information you have requested, as it would prove too costly to do so within the context of the fee regulations.

As you may be aware the current cost threshold is £600 and I estimate that it would cost well in excess of this amount to process your request.

As such, and in terms of Section 16(4) of the Freedom of Information (Scotland) Act 2002 where Section 12(1) of the Act (Excessive Cost of Compliance) has been applied, this represents a refusal notice for the information sought.

By way of explanation, the only way to provide an accurate response to your request would be to manually examine each and every crime report in relation to thefts by shoplifting to establish whether identifiable food items are listed as stolen property. This is an exercise which I estimate would far exceed the cost limit set out in the Fees Regulations.

To illustrate, the most recent published figures show that for the 2021/22 financial year, there were 3, 263 recorded crimes of theft by shoplifting for Greater Glasgow Division. Unfortunately, the only way to access a description of items stolen is via each individual crime report. As such this is an exercise which would far exceed the cost limit set out in the Fees Regulations.

- **Can you give me any further information about how these crimes were resolved - IE, if they resulted in prosecution, etc.**

Police Scotland does not hold prosecution/conviction information. As such, in terms of Section 17 of the Freedom of Information (Scotland) Act 2002, this represents a notice that the information you seek is not held by Police Scotland.

If you are dissatisfied with the way in which Police Scotland has dealt with your request, you are entitled, in the first instance, to request a review of our actions and decisions.

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to [foi@scotland.police.uk](mailto:foi@scotland.police.uk) or by post to Information Management (Disclosure), Police Scotland, Clyde Gateway, 2 French Street, Dalmarnock, G40 4EH.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
