FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

I require a copy of my marriage papers which is an Arabic Document which was being carried by Major Charles Dennis McKee on his person when he passed 21st December 1988 at Lockerbie.

My understanding is this document called "a Muktar Record" was found by Dr Fieldhouse, had not been translated into English since Major McKee read Arabic and has never been translated into English.

My understanding is that my marriage papers in Arabic are held at the Lockerbie Enquiry in Dextar log PD/1324 with references to those contained in Jig file X. I attach a newspapers report where DCI Dalgliesh specifies the relevant files.

I would also like copies of the photographs on which I appear with Major McKee and copies of our photographs from Baalbek carried by Major Charles Dennis McKee at the time of his passing.

I asked previously for these papers without explaining in full what they were. I then asked for a review of the refusal and was ignored.

I am now specifying that I require a copy of my marriage papers and would appreciate if Police Scotland would be so kind as to provide me copies of our photographs.

In terms of section 14(2) of the Freedom of Information (Scotland) Act 2002 I am refusing to process your request on the basis that it is repeated.

I note your attempt to refine your request but the response still stands.

I would also stress that the correct process to access any *personal information* held by Police Scotland is the subject access process.

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to foi@scotland.pnn.police.uk or by post to Information Management (Disclosure), Police Scotland, Clyde Gateway, 2 French Street, Dalmarnock, G40 4EH.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.

As part of our commitment to demonstrate openness and transparency in respect of the information we hold, an anonymised version of this response will be posted to the Police Scotland Freedom of Information <u>Disclosure Log</u> in seven days' time.
