## FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

I am writing to you in regards to finding out further information to why the TTF concert, due to be held on the 3<sup>rd</sup> of December 2022 at the Royal Highland Centre has been refused its license on public safety grounds.

Please could you provide me with information on how many drug related deaths; arrests; hospitalisations and of any drugs were found at a previous TTF concert, held at the Royal Highland Centre, 8<sup>th</sup> of December 2018.

I can confirm that there were no drug related deaths at the event recorded by Police Scotland.

There were two arrests.

We do not have note of any hospitalisations and you may wish to consider contacting NHS Lothian in this regard but we do have recorded that 30 people were treated by welfare and 17 by medical for alcohol, pre-existing conditions and minor injury.

I can confirm that in relation to drugs, a steward search regime was supported by police with 1 tablet being handed to police. No drugs were left in amnesty bins and no drug related issues were reported.

By way of additional information, it is noted that 4 persons were ejected by stewards during the event and 6 persons were refused at the bar.

Please could you also provide me with information on minutes of meetings that have taken place at Police Scotland regards the recent concerns on why TTF haven't been given a license for their concert due to held on 3<sup>rd</sup> of December 2022 at the Royal Highland Centre.

I can confirm that Police Scotland do not hold any minutes in relation to this. As such, in terms of Section 17 of the Freedom of Information (Scotland) Act 2002, this represents a notice that the information requested is not held by Police Scotland.
