FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

Please supply me with the information contained in your records regarding The Hammersmith Police Investigation - Case Number : 6029679/21

Police Scotland are aware that the Metropolitan Police Service received a complaint and a number of documents on 20th December 2021. The Metropolitan Police Service provided the complainers with a crime reference number at that time while they reviewed the documents. Since then, the Metropolitan Police Service have been clear that they have found nothing to suggest any offences or grounds for an investigation, as such no investigation is taking place. This information was communicated to all Chief Constables in the UK. Police Scotland have no further information relating to this crime reference number.

Whilst this is a metropolitan police investigation, which one may discern as serious and organized crime, do Police Scotland have the authority and jurisdiction to accept evidence from Scottish Citizens as Police Scotland although a separate force are still accountable to the UK Parliament.

Police Scotland will assess all complaints made. To date no criminal activity has been identified and no crime reports raised.

Please provide me with the legislation that allows these vaccination center's to still operate whilst there is a live investigation into said serious and organized crime of acts against humanity which breach domestic law and international law such as the Nuremburg Code and the international covenant for civil and political rights.

There is no live investigation ongoing in relation to COVID vaccines, the operation of vaccination centres is a matter for the NHS and public health.

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to foi@scotland.pnn.police.uk or by post to Information Management (Disclosure), Police Scotland, Clyde Gateway, 2 French Street, Dalrnarnock, G40 4EH.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
