## FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

We are writing an article on the multiple robbery that took place on South Street in the early hours of Thursday 17th February. I was wondering whether it would be possible to ask some questions regarding the case. Incidentally, I am also a victim of the case (), and had my laptop stolen.

My questions are:

1) When was Fife Police first alerted to the incident?

2) Which businesses and residences were involved?

3) What were the events that led to the arrest of [] and []?

4) How were you able to identify the aforementioned individuals?

5) Where did the arrest take place?

6) What, to the best of Fife Police's knowledge, were the actions of [] and [] on the night of the incident?

Having considered your request in terms of the above Act, I would advise you that under Section 18 of the Freedom of Information (Scotland) Act 2002 (the Act), Police Scotland can neither confirm nor deny that it holds the information requested by you.

However, if the information was held by the Service, it would be considered exempt in terms of one or more of the exemptions detailed in Section 18 of the Act, which are listed below:

• Section 34(1) - Investigations

• Section 38(1)(a)&(b) - Personal Data

To disclose whether or not information was held would confirm whether or not the individuals referred to are in some way known to Police Scotland.

If any information were held, it would be held for the purpose of an investigation and disclosure of such information would prejudice the prevention and detection of crime and the apprehension or prosecution of offenders.

This should not, however, be taken as conclusive evidence that the information you have requested exists or does not exist.

If you are dissatisfied with the way in which Police Scotland has dealt with your request, you are entitled, in the first instance, to request a review of our actions and decisions.

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to foi@scotland.pnn.police.uk or by post to Information Management (Disclosure), Police Scotland, Clyde Gateway, 2 French Street, Dalmarnock, G40 4EH.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. You can apply <u>online</u>, by email to <u>enquiries@itspublicknowledge.info</u> or by post to Office of the Scottish Information Commissioner, Kinburn Castle, Doubledykes Road, St Andrews, Fife, KY16 9DS.

Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
