FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

I write to enquire if it would be possible to have current crime statistics for the Haymarket Area.

Clarified as:

Three years' worth of crime data for the area within a quarter mile radius of 1 Haymarket Square, EH125EY

The tables at the end of this document provides the number of Recorded and Detected crimes, within a quarter mile radius around Haymarket Train Station, Edinburgh from 1st January 2019 – 30th April 2022.

All statistics are provisional and should be treated as management information. All data have been extracted from Police Scotland internal systems and are correct as at 26th May 2022.

The Recorded Crimes are extracted using the Date Raised, and then mapping the Crimes using ArcGIS software. Records within a quarter mile radius of Haymarket Train Station, Edinburgh, were then selected. Please note, that crimes relating to the Covid-19 are not included.

If you are dissatisfied with the way in which Police Scotland has dealt with your request, you are entitled, in the first instance, to request a review of our actions and decisions. Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to foi@scotland.police.uk or by post to Information Management (Disclosure), Police Scotland, Clyde Gateway, 2 French Street, Dalmarnock, G40 4EH.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.

As part of our commitment to demonstrate openness and transparency in respect of the information we hold, an anonymised version of this response will be posted to the Police Scotland Freedom of Information <u>Disclosure Log</u> in seven days' time.
