FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

Information request 1: Electric scooter offences

The number of disposals relating to electric scooters in Scotland broken down:

- · for each of the last three years you have on record,
- by type of disposal,
- · by each police command area in Scotland.

Information request 2: Electric scooter offenders' age

The number of people sentenced for offences relating to electric scooters in Scotland broken down:

by age of offender - ie. how many were under 18 and how many over 18.

Information request 3: Electric scooter offenders' drivers' licence The number of people sentenced for offences relating to electric scooters in Scotland broken down:

by how many had a drivers' licence and how many didn't.

Information request 4: Electric scooter confiscation

The number of electric scooters seized by police broken down:

- for each of the last three years you have on record,
- by reason
- by each police command area in Scotland.

In response to these questions, I regret to inform you that I am unable to provide you with the information you have requested, as it would prove too costly to do so within the context of the fee regulations.

As you may be aware the current cost threshold is £600 and I estimate that it would cost well in excess of this amount to process your request.

As such, and in terms of Section 16(4) of the Freedom of Information (Scotland) Act 2002 where Section 12(1) of the Act (Excessive Cost of Compliance) has been applied, this represents a refusal notice for the information sought.

By way of explanation, crimes in Scotland are recorded in accordance with the Scottish Government Justice Department (SGJD) offence classification codes and are not thereafter sub-categorised.

In this instance there is no specific SGJD classification relevant to your request and any such incident would be recorded under wider Road Traffic offences.

In relation to your request for seizures of e-scooters, I must advise you that there is no facility available on Police Scotland's systems which allow for productions which have been seized to be searched by type, i.e. scooter/e-scooter/vehicle etc.

The only way to provide an accurate response to your request would be to carry out case by case assessment of all road traffic offences and any other potentially relevant crimes, of which there would be thousands. As such, this is an exercise which I estimate would far exceed the cost limit set out in the Fees Regulations.

Information request 5: Electric scooter thefts

The number of electric scooters reported to the police as stolen broken down:

- · for each of the last three years you have on record,
- by each police command area in Scotland.

I regret to inform you that I am unable to provide you with the information you have requested, as it would prove too costly to do so within the context of the fee regulations.

By way of explanation, there are no relevant markers available on Police Scotland crime recording systems which allow the automatic retrieval of this level of information, and so it is not possible to search for crime reports based upon the type of property stolen.

Any such incident would be recorded under the general crime classifications of Theft, or Theft by Housebreaking etc. all of which would have to be individually examined to determine whether the property stolen was an electric scooter.

As such, and in terms of Section 16(4) of the Freedom of Information (Scotland) Act 2002 where Section 12(1) of the Act (Excessive Cost of Compliance) has been applied, this represents a refusal notice for the information sought.

If you are dissatisfied with the way in which Police Scotland has dealt with your request, you are entitled, in the first instance, to request a review of our actions and decisions. Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to foi@scotland.police.uk or by post to Information Management (Disclosure), Police Scotland, Clyde Gateway, 2 French Street, Dalmarnock, G40 4EH.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
