FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

The information requested below relates to the sexual offences Scotland act sections 33 and 34.

In regards to our Fife division and Tayside division (where time allows)

1. I would like to know the number of "victims" who were NOT of the ages between 13 and under 16, ie people who impersonated an individual between 13 and under 16.

Fife Division: 10 Tayside Division: 6

Please note that these figures relate to number of victims/complainers and not number of crimes.

I would also advise that there is one police report in our Fife Division where the victim age is unconfirmed and so it is not possible to confirm whether a pseudo age was used or not. This related to a mobile phone with relevant messages being found by a member of the public.

2. The number of crimes reported by "Vigilante" groups who have taken the law into there own hands to entrap people they believe to be commuting an offence. (A vigilante being defined as " a member of a volunteer committee organized to suppress and punish crime summarily (as when the processes of law are viewed as inadequate) broadly: a self-appointed doer of justice")

Firstly I must advise that Police Scotland does not use the term "vigilante group" and instead refers to activist groups that report Online child sexual abuse and exploitation offending as Online Child Sexual Abuse Activist Groups (OCAG). I have therefore based my response on our definition of OCAG and not as noted above by yourself.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
