## FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

**a) How much money was lost to fraudsters and scammers within the force's jurisdiction in 2020 and 2021 and so far in 2022? (If the force records fraud and scams as separate crimes, please provide data for both)**

**b) Of this sum, how much was recovered from the perpetrators?**

Having considered your request in terms of the Act, I regret to inform you that I am unable to provide you with the information you have requested, as it would prove too costly to do so within the context of the fee regulations.

As you may be aware the current cost threshold is £600 and I estimate that it would cost well in excess of this amount to process your request.

As such, and in terms of Section 16(4) of the Freedom of Information (Scotland) Act 2002 where Section 12(1) of the Act (Excessive Cost of Compliance) has been applied, this represents a refusal notice for the information sought.

By way of explanation, the only way to determine whether a fraud was in relation to a scam and the values involved would be to manually read each and every relevant crime report. I can further advise you that some offences of this nature may also be recorded as Proceeds of Crime Act. To illustrate, the most recent published figures show that as at Q2 2022/23 financial year, there were 8,732 recorded crimes of Fraud. As each of these reports as a minimum would require reviewing this would be an exercise which would far exceed the cost limit set out in the Fees Regulations.

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to [foi@scotland.police.uk](mailto:foi@scotland.police.uk) or by post to Information Management (Disclosure), Police Scotland, Clyde Gateway, 2 French Street, Dalmarnock, G40 4EH.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
