## FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

### **How many bicycles have been reported to the police as stolen from each postcode district in this region from 01/01/18 to now?**

Please find attached a table which provides recorded Theft of Pedal Cycle crimes, by postcode district for the period 01 January 2018 - 06 July 2022 (calendar years). All statistics are provisional and should be treated as management information. All data have been extracted from Police Scotland internal systems and are correct as at 07 July 2022.

### **If possible, information on the bicycle models reported stolen? If possible, information on the stated values of bicycles reported stolen? The number of bicycles successfully returned to their owners from 01/01/18 to now.**

Having considered these questions in terms of the Act, I regret to inform you that I am unable to provide you with the information you have requested, as it would prove too costly to do so within the context of the fee regulations.

As you may be aware the current cost threshold is £600 and I estimate that it would cost well in excess of this amount to process your request.

As such, and in terms of Section 16(4) of the Freedom of Information (Scotland) Act 2002 where Section 12(1) of the Act (Excessive Cost of Compliance) has been applied, this represents a refusal notice for the information sought.

By way of explanation, the only way to provide an accurate response to your request would be to examine each and every one of the recorded thefts shown in the above table provided to establish the models/value etc of each cycle taken. Unfortunately there are no relevant markers which allow the automatic retrieval of this level of information. As such this an exercise which would far exceed the cost limit set out in the Fees Regulations.

If you are dissatisfied with the way in which Police Scotland has dealt with your request, you are entitled, in the first instance, to request a review of our actions and decisions.

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to [foi@scotland.pnn.police.uk](mailto:foi@scotland.pnn.police.uk) or by post to Information Management (Disclosure), Police Scotland, Clyde Gateway, 2 French Street, Dalmarnock, G40 4EH.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
