FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

- A) Please supply a full statistical count and disclosure of all accusations of the crimes of rape and sexual violence said to be committed by any genetic woman or girl towards any genetic man or boy between 19/3/2019 19/3/2022 that were reported to Police Scotland and subsequently found to be true.
- B) Please supply a full statistical count and disclosure of all recorded accusations of ablest, anti-Catholic or misandristic hate crimes said to be committed by any genetic woman or girl against any genetic Catholic disabled man, priest or boy between 19/3/2019 19/3/2022 that were reported to Police Scotland and subsequently found to be true.
- C) Please supply a full statistical count and disclosure of all accusations of the crimes of domestic physical violence or other domestic abuse said to be committed by any genetic woman or girl towards any genetic man or boy between 19/3/2019 19/3/2022 that were reported to Police Scotland and subsequently found to be true.

"True" is to mean accusations of crime in which the accused genetic woman or girl was found "Guilty" by a jury of 15 in a Court of Scottish Criminal Law.

"False" is to mean accusations of crime in which the accused woman or girl has not been tried, was found "Not-Proven" or found "Not-Guilty" by a jury of 15 in a Court of Scottish Criminal Law. I am not interested in false accusations.

Please respect Article 11 of The Universal Declaration of Human Rights of all and any genetic woman or girl when handling this request.

*Genetic man and genetic woman is to mean those 16+ except in so far as the criminal law of Scotland may state otherwise in individual cases. Genetic girl and genetic boy is to mean those 15- except in so far as the criminal law of Scotland may say so otherwise in individual cases.

In the case of children, I do not request a disclosure of any cases or the details of any child just a statistical count.

Having considered these questions in terms of the Act, I can confirm that section 17 of the Act applies - the information sought is *not held* by Police Scotland.

Based on your definition of 'true' provided above, you are seeking information about crime reports that resulted in a quilty verdict at court following a jury trial.

Police Scotland do not hold conviction information or information about the nature of any criminal trials that result from prosecution reports submitted to COPFS.

If you are dissatisfied with the way in which Police Scotland has dealt with your request, you are entitled, in the first instance, to request a review of our actions and decisions.

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to foi@scotland.police.uk or by post to Information Management (Disclosure), Police Scotland, Clyde Gateway, 2 French Street, Dalmarnock, G40 4EH.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
