## FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

**Could you please provide me with the number of assaults on taxi drivers in Inverclyde broken down by offence type (ABH, common assault, etc), month and year the assault occurred and the outcome (charge, caution, etc).**

In response to this question, I regret to inform you that I am unable to provide you with the information you have requested, as it would prove too costly to do so within the context of the fee regulations.

As you may be aware the current cost threshold is £600 and I estimate that it would cost well in excess of this amount to process your request.

As such, and in terms of Section 16(4) of the Freedom of Information (Scotland) Act 2002 where Section 12(1) of the Act (Excessive Cost of Compliance) has been applied, this represents a refusal notice for the information sought.

By way of explanation, 'occupation' of an individual is not a mandatory field on Police Scotland's crime recording systems and may only be recorded where relevant.

Our crime recording systems also have no facility whereby the occupation of the victim can be easily extracted, nor is it possible to carry out a search by occupation or whether the victim was working at the time of the offence.

As such, case by case assessment of all violent offences would be required to establish whether they were relevant to your request.

Although you have not provided a time frame, even if we were to individually examine all violent offences for one year, there would still be a vast number of reports requiring assessment. As such, this is an exercise which I estimate would far exceed the cost limit set out in the Fees Regulations.

If you are dissatisfied with the way in which Police Scotland has dealt with your request, you are entitled, in the first instance, to request a review of our actions and decisions.

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to [foi@scotland.police.uk](mailto:foi@scotland.police.uk) or by post to Information Management (Disclosure), Police Scotland, Clyde Gateway, 2 French Street, Dalmarnock, G40 4EH.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
