This is an information request relating to purchases of LGBT merchandise, visits to LGBT pride parades, and the wrapping of police vehicles in rainbow decorations Please include the information for each of the following periods; 2019-20, 2020-21, 2021-22:

 Annual purchases of LGBT+ merchandise (for example, rainbow flags, bunting, lanyards, wristbands, stickers, balloons, pins) including the total quantity of LGBT+ merchandise purchased and the expenditure. Please provide a breakdown of what was purchased

I can confirm that no Police Scotland funds were used to purchase any of the above noted merchandise.

To be of some assistance however, I can advise that the Scottish LGBTI Police Association is funded by a grant provided by the Scottish Government and they did have some expenditure in this regard.

The association spent the following amounts on various promotional items, printing, ICT subscriptions, travel and conferences etc over the period requested.

Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
