## **FREEDOM OF INFORMATION (SCOTLAND) ACT 2002**

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

### **Crime Stats FK10**

**Please could you provide crime data for the area, ideally dating back one to three years and for the following crime types:**

- **Anti-social behaviour**
- **Burglary**
- **Criminal damage and arson**
- **Drugs**
- **Public order / protest**
- **Robbery**
- **Theft from the person**
- **Vehicle crime**
- **Violence and sexual offence**
- **Possession of weapons**

In response to your request, please see the end of this letter for all crimes at postcode FK10 for the period 1 January 2019 to 30 November 2022, by calendar year.

All statistics are provisional and should be treated as management information. All data have been extracted from Police Scotland internal systems and are correct as at 15th December 2022.

The crimes are extracted using the date raised, and then mapping the crimes to the specified postcode using ArcGIS software (based on the Grid East and Grid North). Please note, not all records have a Grid East and Grid North. Only records with a Grid East and Grid North are plotted and selected.

Please note, that crimes relating to the Covid-19 pandemic are not included.

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to [foi@scotland.police.uk](mailto:foi@scotland.police.uk) or by post to Information Management (Disclosure), Police Scotland, Clyde Gateway, 2 French Street, Dalmarnock, G40 4EH.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
