FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

Could I have the figures for car theft in Scotland over the past three years 2021, 2020, 2019 and so far this year in 2022.

Having considered your request in terms of the Act, I regret to inform you that I am unable to provide you with the information you have requested, as it would prove too costly to do so within the context of the fee regulations.

As you may be aware the current cost threshold is £600 and I estimate that it would cost well in excess of this amount to process your request.

As such, and in terms of Section 16(4) of the Freedom of Information (Scotland) Act 2002 where Section 12(1) of the Act (Excessive Cost of Compliance) has been applied, this represents a refusal notice for the information sought.

By way of explanation, thefts of cars would fall into the more general classification of Theft of a Motor Vehicle and are not thereafter sub classified into the type of vehicle. I can also advise you that if a vehicle is stolen during a housebreaking this will be recorded as such rather than as separate crimes. Therefore the only way to establish how many cars have been stolen is to manually examine each and every one of the relevant crime reports. As such this is an exercise which I estimate would far exceed the cost limit set out in the Fees Regulations.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
