FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

I wish to make a request for information under freedom of legislation, in relation to policing of temporary traffic regulation orders which restrict traffic during certain times outside several primary schools in Angus, Dundee and Perth and Kinross.

I would like to know how many penalty notices have been issued for contraventions of the TTROs in force in respect of the following primary schools (listed with the streets where TTROs are in force). For each penalty notice I would like to know which school it was associated with and what date and time of day it was issued.

In both cases I would like the information from when the TTROs came into force.

I can advise you that these types of restrictions are the responsibility of each local authority. Therefore in terms of Section 17 of the Freedom of Information (Scotland) Act 2002, this represents a notice that the information you seek is not held by Police Scotland.

I would also like details of the dates and times when police officers have attended each of the locations listed to conduct monitoring or patrols in relation to the TTROs.

I can advise you that Police Scotland do not record when patrols visit school premises or surrounding areas. As such, in terms of Section 17 of the Freedom of Information (Scotland) Act 2002, this represents a notice that the information you seek is not held by Police Scotland.

If you are dissatisfied with the way in which Police Scotland has dealt with your request, you are entitled, in the first instance, to request a review of our actions and decisions.

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to foi@scotland.police.uk or by post to Information Management (Disclosure), Police Scotland, Clyde Gateway, 2 French Street, Dalmarnock, G40 4EH.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
