Your recent request for information is replicated below, together with our response.

1. Police officer numbers by region, annually since 2016

The information sought is held by Police Scotland, but I am refusing to provide it in terms of section 16(1) of the Act on the basis that the section 25(1) exemption applies:

"Information which the applicant can reasonably obtain other than by requesting it [...] is exempt information".

2. Foot patrol hours by region, annually since 2016

Having considered your questions in terms of the Act, section 17 of the Act would apply as the specific information requested is not held by Police Scotland.

By way of explanation, police officer deployment is dynamic and will plans will change regularly as a result of intelligence and/ or operational need.

Officers can be diverted from what might be described as a routine patrol in order to respond to an ongoing incident etc.

Similarly, patrols may become 'routine' over a period of days/ weeks as a result of a particular incident or particular community concerns etc. but then resources are deployed elsewhere as the situation changes.

We do not record what part of an officer's shift is spent on patrol as opposed to dealing with particular incidents etc.

Officers will be deployed in real time according to operational need.

3. Number of police stations closed since 2016

There is no requirement to record when a police station is closed, as such in terms of section 17, the information requested is not held.

To be of assistance, I can provide the number of stations sold.

Please see the table below, additionally, please note, Scotland's policing estate has been built up over the course of several decades and some buildings are no longer in the right place or operationally fit for purpose. Many police station sales were as a result of properties declared surplus by Legacy Forces although the sales occurred post-formation of Police Scotland. The majority of these decisions, which took place prior to the formation of Police Scotland, were taken after lengthy and detailed consultation with our partners and local communities and this process remains the same today. In the vast majority of cases, police stations which were closed were moved to new modern co-located accommodation within the same towns or officers were moved to new police stations nearby.

4. Number of stations requiring repairs or deemed unfit for purpose, by region

I can advise that one station was closed due to health and safety concerns.
