FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

The Compensation and Surrender Scheme was a Scottish Government scheme which was supported by Police Scotland. The scheme only applied to certain types of weapons which have been illegal to sell and import for a number of years.

Police Scotland is supporting the Scottish Government's surrender and compensation scheme as part of the Offensive Weapons Act. The scheme is designed to encourage owners of specific offensive weapons to hand them into designated police stations until 30 September and ahead of the new legislation which will see private ownership become illegal. All weapons surrendered will be destroyed in a controlled manner on conclusion of the scheme and in line with previous weapons amnesties.

The number of weapons handed over to Police Scotland under the Surrender and

Compensation Scheme

153 weapons in total surrendered under the scheme. 42 of these weapons were from the

prescribed list and eligible to apply for compensation (39 surrendered with claim for

compensation / 3 had no claim for compensation submitted).

111 weapons were surrendered as part of the scheme but were not of a type from the

prescribed list and so were not eligible to claim for compensation.

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to <u>foi@scotland.pnn.police.uk</u> or by post to Information Management (Disclosure), Police Scotland, Clyde Gateway, 2 French Street, Dalmarnock, G40 4EH.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
