FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

I am writing to make a request under the Freedom of Information Act for information regarding temporary average speed cameras that were installed on the M74 in Lanarkshire.

Maintenance on the motorway took place between August and December 2022. Average speed cameras were installed northbound at junction 6 with a 40mph restriction in place.

Specifically, I would like the following information, from August 8, 2022, to December 12, 2022, please:

• The number of fixed penalty notices issued – broken down by date (as long as this is within the cost limits, please)

The following information is provided in relation to vehicles detected speeding by the Safety Camera Unit and subsequently issued with a Conditional Offer of Fixed Penalty Notice. Furthermore it is also highlighted that not all Safety Camera Unit detected speeding offences are eligible for a Conditional offer of Fixed Penalty Notice as there are offences which are reported directly to the Procurator Fiscal due to a number of reasons, e.g. excessive speed, ineligible due to number of points driver already accrued, driver declines to accept COFPN as he wishes to attend court, etc.

The following information is correct as of 9 December 2022. As the information is taken from a live database the numbers are subject to change as updates are received.

Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
