FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

Please, first of all, accept my sincere apologies for the delay in providing a response to your request.

For ease of reference, your request is replicated below together with the response.

Road collision which occurred on 31/07/2020 at Percival Road (B930), Buckhaven, Fife. The exact locus is a bend approx 340 metres south of the T junction with Standing Stane Road.

Please provide details on the number of road traffic collisions which have occurred at this bend since records began?

If possible, are you able to provide the number of recorded collisions after this date, and confirm the direction of travel of the vehicles (again if possible)

In response to your request, please find below a Table which provides Road Traffic Collisions on the B930, by severity. Specified areas have been selected using GIS Mapping (based on the Grid East and Grid North) between Percival Cottage and the properties prior to the junction with Standing Stane Road have been selected. The data is for the period 01 January 2006 to 31 December 2021

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
