FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

I am trying to obtain information on motor vehicle incidents (ie car accidents, speeding, pedestrian or other road user safety issues) that have happened in my area over the last 10 years. I have been advised by South Lanarkshire Council that I need to get this information from Police Scotland.

As such, can you please provide a breakdown of all reported incidents for the last 10 years, in the following postcodes: ML119UL, ML119UP, ML119UW. Ideally giving details of the number of incidents by type per year.

Please see the table below, which contains the information requested.

If you are dissatisfied with the way in which Police Scotland has dealt with your request, you are entitled, in the first instance, to request a review of our actions and decisions.

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to foi@scotland.police.uk or by post to Information Management (Disclosure), Police Scotland, Clyde Gateway, 2 French Street, Dalmarnock, G40 4EH.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.

As part of our commitment to demonstrate openness and transparency in respect of the information we hold, an anonymised version of this response will be posted to the Police Scotland Freedom of Information [Disclosure Log](#) in seven days' time.

All statistics are provisional and should be treated as management information. All data have been extracted from Police Scotland internal systems and are correct as at 2nd March 2022.

1. The data was extracted using the incident's raised date and by selecting the final incident type 'TR-41' (Road Traffic Collision), 'TR-43' (Road Traffic Matter), 'TR-44' (Vehicle Pursuit), 'TR-54' (Road Traffic Offence).
2. No incident types have been excluded.
3. The Grid East and Grid North attributed to the Storm Incident were plotted on an ArcGIS Map. Incidents located within the specified postcodes were then selected. Please note, the Grid East and Grid North relates to where Police Officers are directed to attend.
4. Please note, each record would need to be read to confirm the circumstances, and if Police Officers attended the location.
