FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

How many fines have been handed out to drivers for breaching the Glasgow City Council School Streets Car Free Zone from August 2020 to June 2021 in the following areas: Elmwood Avenue and Elmwood Lane; Otago Street and Westbank Quadrant; Lourdes Avenue; Caldwell Avenue and Broadlie Drive; Arrochar Drive; Lourdes Primary access road off Berryknowes Road; Carmichael Place, Cartside Street, Cartvale Road and Dundrennan Road; Kern Avenue, Kern Place, and Kern Gardens; Herma Street; Redford Street; Dunard Street and Braeside Street; Craigbank Drive, Drumbeg Drive and Prestwick Street; Fortrose Street; Dorchester Place and Weymouth Drive; Kingsbridge Drive; Friarton Road and Ashmore Road; Mossspark Square; Ferndale Court; Duncan Avenue, Earlbank Avenue, Ormiston Avenue and Norse Road; Glen Orchy Drive, Glen Orchy Place and Glen Orchy Grove; David Street; Dove Street; Crompton Avenue; Anwoth Street; Primrose Street and Fore Street.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
