How many staff have made the force aware that they have Long Covid? Please break the figure down to show any categorisations (i.e. officers, call handlers) of staff who have Long Covid to date.

How many of these staff have been signed off work by their doctor for any period of time due to Long Covid.

In response to your request, I can advise the following.

The data presented has been extracted from Police Scotland's System to Co-ordination Personnel and Establishment (SCOPE) database.

This data has been extracted for individuals who are categorised under the absence reason 'COVID-19 – Post Covid Syndrome' which is used for employees who have had a Covid related absence for more than 12 weeks.

It is possible that an individual has been categorised absent with 'Post Covid Syndrome' for a period of time before another diagnosis is reached.

Please note that it is possible that the same individuals counted in the 2020/21 data have remained absent and are also included in the 2021/2022 data.

Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
