Having considered your request in terms of the Act, I regret to inform you that I am unable to provide you with the information you have requested, as it would prove too costly to do so within the context of the fee regulations.

As you may be aware the current cost threshold is £600 and I estimate that it would cost well in excess of this amount to process your request.

As such, and in terms of Section 16(4) of the Freedom of Information (Scotland) Act 2002 where Section 12(1) of the Act (Excessive Cost of Compliance) has been applied, this represents a refusal notice for the information sought.

To explain, crimes are recorded by offence classification using Scottish Government Justice Department crime classification codes rather than by type of business or profession. As a result, the only way to provide an accurate response to your request would be to read through each and every crime report for the years requested to establish if the type of premises is detailed and then further examine in order to answer the specific details of your request. Given that there were in excess of 1900 Hate related incidents alone in the time period requested that would have to be researched, this is an exercise which I estimate would far exceed the cost limit set out in the Fees Regulations.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision.
