FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

The number of Fatal Accident Inquiries involving Police Scotland employees where solicitors representing Police Scotland employees in said Inquiries had their fees paid by Police Scotland.

The number of instances (if any) where Police Scotland received a request but refused pay the legal of fees on an employee who was involved in a Fatal Accident Inquiry.

The total fees paid to solicitors for their work representing Police Scotland employees at Fatal Accident Inquiries.

Having considered your request in terms of the above Act, I regret to inform you that I am unable to provide you with the information you have requested, as it would prove too costly to do so within the context of the fee regulations. As you may be aware the current cost threshold is £600 and I estimate that it would cost well in excess of this amount to process your request. As such, and in terms of Section 16(4) of the Freedom of Information (Scotland) Act 2002 where Section 12(1) of the Act (Excessive Cost of Compliance) has been applied, this represents a refusal notice for the information sought.

By way of explanation, from 2015, there have been 48 Fatal Accident Inquiries (FAI) where officers potentially could have been cited. To gather the information requested would require extensive research not only of each individual Case files, but each individual entry within it and thereafter cross referred to a related data bases to establish if legal costs were refused, paid and the full costs. If we estimate that it would take at least 2 hours to research each file 48 x 2 hours would total 96 hours and exceed the time and cost threshold set by ministers.

If you are dissatisfied with the way in which Police Scotland has dealt with your request, you are entitled, in the first instance, to request a review of our actions and decisions.

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to foi@scotland.police.uk or by post to Information Management (Disclosure), Police Scotland, Clyde Gateway, 2 French Street, Dalmarnock, G40 4EH.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
