FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

To provide some context to our response, it may be helpful to first outline that in respect of police officers, their conduct is assessed against our Standards of Professional Behaviour, details of which can be found at the following link:

Where it is inferred that an officer has committed a criminal offence, whether on or off duty, all proceedings under the Police Service of Scotland (Conduct) Regulations 2014 normally cease until the Crown Office and Procurator Fiscal Service (COPFS) has made a decision on whether criminal proceedings will be instigated in relation to that officer.

After any criminal proceedings have concluded, whatever the outcome, a preliminary assessment is carried out under Regulation 10 of the Police Service of Scotland (Conduct) Regulations 2014. Should an officer's behaviour be assessed to have breached the Standards of Professional Behaviour and a misconduct investigation is required, the officer is served with of a Notice of Misconduct Investigation form. The purpose of any investigation is to gather evidence to establish the facts and circumstances of the alleged misconduct and if there is a case to answer.

Our misconduct procedures aim to provide a fair, open and proportionate method of dealing with alleged misconduct. The procedures are intended to encourage a culture of learning and development for individuals and/or the organisation; however, disciplinary action can be undertaken when circumstances require.

The decision to suspend an officer will only be taken by the Deputy Chief Constable (DCC) Designate or, in their absence, a deputising DCC. This course of action will normally only be taken following a rigorous and objective examination of the circumstances prior to any decision being made. Regular reviews of an officer's suspension are carried out to ensure suspension remains appropriate and proportionate to mitigate any risk the officer may pose to the public and / or the organisation. For ease of reference, your request is replicated below together with the response.

As at 26/07/2022, the number of officers currently suspended from duty broken down by rank.

A total of 46 Police Officers were suspended as at 26/07/2022. Details of rank are provided in the following table.

As at 26/07/2022, the number of officers who are suspended as a result of being under criminal investigation, broken down by rank.

Please note, as mentioned above, consideration of criminal proceedings normally take precedence over any subsequent misconduct investigation. An officer may be suspended whilst 'being under criminal investigation', including once a report has been submitted to COPFS for consideration of criminal proceedings. Once criminal proceedings have concluded, or if COPFS decide not to take any criminal proceedings, an officer may remain suspended pending consideration of the circumstances from a misconduct perspective.

The figures provided below include officers who are either, as at 26/07/22, subject of a criminal investigation, awaiting decision from COPFS regarding whether criminal proceedings will be instigated or their circumstances are under consideration from a misconduct perspective.

As at 26/07/2022, the number of officers who are repositioned as a result of being under non-criminal, misconduct investigation, broken down by rank. Please distinguish between misconduct and gross misconduct.

For the purposes of this question, "repositioned" has been interpreted as officers subject to restricted duties in relation to a formal misconduct investigation as at 26/07/2022. This therefore does not include officers who were suspended at this date.

Furthermore, "misconduct investigation" refers to Police Officers subject to a formal misconduct investigation as per regulation 11 of The Police Service of Scotland (Conduct) Regulations 2014. The longest period of suspension being served by a Police Officer was a total of 1,177 days, as at 26/07/2022. This officer holds the rank of Constable.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision.
