FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

1. How many incidences of antisocial behaviour were recorded by your force in every year between 2010 and 2022.

Please be advised that statistics regarding Antisocial Behaviour incidents are publicly available.

As such, in terms of Section 16 of the Freedom of Information (Scotland) Act 2002, I am refusing to provide you with the information sought. Section 16 requires Police Scotland when refusing to provide such information because it is exempt, to provide you with a notice which:

- (a) states that it holds the information,
- (b) states that it is claiming an exemption,
- (c) specifies the exemption in question and
- (d) states, if that would not be otherwise apparent, why the exemption applies.

I can confirm that Police Scotland holds the information that you have requested and the exemption that I consider to be applicable is set out at Section 25(1) of the Act - information otherwise accessible:

"Information which the applicant can reasonably obtain other than by requesting it under Section 1(1) is exempt information"

- 2. How many of the above incidences of antisocial behaviour recorded by your force resulted in:
- a) ASB civil injunctions
- b) Community protection notices
- c) Public space protection orders

- d) Dispersal powers
- e) closure powers
- F) criminal behaviour orders
- g) no further action
 - 3. In how many instances did your force apply, or encourage the prosecution to apply, for a Criminal Behaviour Order?

In response to these questions, I can advise you that several of the options listed do not extend to Scotland but notwithstanding, we would have to cross refer all incidents with other information - there were over 322,000 antisocial behaviour incidents recorded in Scotland. As such Section 12 of the Act - Excessive Cost of Compliance would apply.

If you are dissatisfied with the way in which Police Scotland has dealt with your request, you are entitled, in the first instance, to request a review of our actions and decisions.

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to foi@scotland.police.uk or by post to Information Management (Disclosure), Police Scotland, Clyde Gateway, 2 French Street, Dalmarnock, G40 4EH.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.

As part of our commitment to demonstrate openness and transparency in respect of the information we hold, an anonymised version of this response will be posted to the Police Scotland Freedom of Information <u>Disclosure Log</u> in seven days' time.
