#### FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, and because of the similarities both requests have been combined to include both timescales and subsequent clarifications. This is replicated below together with the response.

You subsequently clarified that you wanted us to include information on all Employment Tribunals *underway* during the dates specified in the respective FOI requests, irrespective of start dates - so therefore all Employment Tribunals underway during, or running from 2015 to 2018 and from 2018 to the current date.

You also clarified that you wanted us to include information for those employment tribunal cases which resolved short of an official determination hearing and to include any which progressed to an Employment Appeal Tribunal.

On that basis the following information is provided:

From a) 2015 to 2018 incl. and b) 2018 to date,

1. For each calendar year, how many Employment Tribunal cases in relation to Police Scotland and the Scottish Police Authority are Police Scotland currently involved in?

I can advise that at the time of request there are 26 such cases ongoing.

#### Details of Individual solicitors / lawyers:

The above recorded information is considered to be exempt in terms of the Freedom of Information (Scotland) Act 2002 (the Act).

Section 16 of the Act requires Police Scotland to provide you with a notice which:

- (a) states that it holds the information,
- (b) states that it is claiming an exemption,
- (c) specifies the exemption in question and
- (d) states, if that would not be otherwise apparent, why the exemption applies.

Where information is considered to be exempt, this letter serves as a Refusal Notice that information is held and an explanation of the appropriate exemption is provided.

I can confirm that Police Scotland holds the information requested. The exemption that I consider to be applicable is:

#### Section 33(1)(b) - Commercial Interests

This provides that information is exempt information if its disclosure would, or would be likely to, prejudice substantially the commercial interests of any person (including, without prejudice to that generality, a Scottish public authority).

The information requested is a specific part of the tender process with Police Scotland. As you may be aware the tendering process is open to competition and if utilised, companies are invited to submit their tender bid with details of the costs and processes they would use for the successful completion of the contract.

Accordingly, disclosure would prejudice Police Scotland's commercial interests in relation to future tenders.

Any relevant information supplied by a tender company is provided in the expectation that whilst remaining relevant, details within their tender bid, which is commercially sensitive, will be held by Police Scotland and not disclosed to another organisation which may gain a competitive advantage in receiving this information.

Legal advice and representation is a specialised, competitive area, and there are adequate concerns about the quality of service that would be provided, and the reputational damage to the service, through making the information available to competitors through public disclosure.





This level of detail is not generally publicly available, and any disclosure sets out the overall costs to the legal firm in each case.

This exemption is subject to the public interest test in section 2(1)(b) of FOISA.

It could be argued that disclosure of the requested information would allow greater scrutiny of the way public funds are spent and would increase accountability and transparency in terms of this spending. Police Scotland is a publicly funded organisation and therefore the Service has an obligation to obtain best value for money with particular services.

That said, the purpose of the tender process is to ensure that all options are presented to Police Scotland and from there the best option in terms of service and cost is selected. In order to do this, it is essential to maintain working relationships with companies that tender their services. As such, Police Scotland will not disclose any information that would impact on the ability to do both. The public interest would not be served if it were no longer possible to engage companies or individuals in a tender offer if they believed that conducting business with Police Scotland would result in their confidential financial information being released.

#### Counsel:

I have indicated within the table above where Counsel was instructed in seven cases.

I can confirm that sums paid to Counsel in respect of two of the cases from 2018 were £29,040 and £52,500 respectively.

Regarding the payments made in the other five cases, instruction was made via our external agents and those fees were included within the total external agent spend i.e. our external agents included this outlay within their invoices.

Accordingly we do not record this information separately and it has not been possible to ascertain the fees paid to counsel in five of the seven cases. In terms of Section 17 of the Act, this letter represents a formal notice that information is not held.

# 3 ii) Details of any joint capacity or instruction with the Scottish Police Authority in connection with Tribunals?

We have not instructed any solicitors or counsel in any joint capacity with the SPA and for this reason I must respond in terms of Section 17 – Information not Held.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
