I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

1) The total cost of the policing operation relating to the death of Queen Elizabeth II, broken down if possible by day.

I must advised that Police Scotland do not currently hold this information. As such, in terms of Section 17 of the Freedom of Information (Scotland) Act 2002, this represents a notice that the information requested is not held by Police Scotland.

By way of explanation, claims for overtime as well as mutual aid recovery claims are still in progress and will take some time to be received and then processed. At present we therefore do not have a total cost figure. We do not have an estimated time this will be completed at present.

2) A list of forces involved, i.e. whether any police from outwith of Scotland were involved and if so, which ones.
