FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

The number of people who have been arrested and/or charged in relation to match fixing in Scotland between 1 April 2017 and 31 March 2022.

Can this be broken down into yearly figures: 2017/18, 2018/19 etc, and be separated into no. of arrests and no. of individuals charged.

Of those either arrested and/or charged, can you also provide detail of whether they are either an employee of a football club or not.

Having considered your request in terms of the Act, I regret to inform you that I am unable to provide you with the information you have requested, as it would prove too costly to do so within the context of the fee regulations.

As you may be aware the current cost threshold is £600 and I estimate that it would cost well in excess of this amount to process your request.

As such, and in terms of Section 16(4) of the Freedom of Information (Scotland) Act 2002 where Section 12(1) of the Act (Excessive Cost of Compliance) has been applied, this represents a refusal notice for the information sought.

To explain, Police Scotland records crimes in accordance with the Scottish Government Justice department's Classification of Crimes and Offences. There is no offence classification specifically related to match fixing. Such offences involving match fixing could be recorded under a variety of more generic crimes which cannot be searched on the basis that they relate to football/ match fixing. This is an exercise that would far exceed the cost limit set out in the Fees.

If you are dissatisfied with the way in which Police Scotland has dealt with your request, you are entitled, in the first instance, to request a review of our actions and decisions.

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
