### FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

In response to your request, it is important to provide some general context. Police Scotland defines a **hate incident** as '*any incident which is perceived by the victim or any other person to be motivated (wholly or partly) by malice and ill-will towards a social group but which does not constitute a criminal offence.*'

Police Scotland defines a **hate crime** as, 'any crime which is perceived by the victim or any other person, to be motivated (wholly or partly) by malice and ill-will towards a social group.'

Social groups are identified in accordance with the Lord Advocates guidelines on Aggravations of Offences against Prejudice i.e. race, sexual orientation, religion/faith, disability or transgender identity.

Additionally, it is worthy of note that the figures provided relate to crimes and incidents recorded as being aggravated by the identified specific prejudice. Victims of hate crimes/incidents do not have to be a member of any of the protected groups in order to be a victim. For example, an individual who is the victim of a transphobic incident does not have to be transgender, or disclose their transgender identity, for this to be perceived, recorded and investigated as a hate related incident.

# 4. With respect to non-crime hate incidents that were so recorded due to the hate element being related to 'gender identity', 'gender reassignment' or 'transphobia'(or whichever similar term the Force may use) please provide a detailed breakdown of the specific type of incident involved.

In response to your request, I regret to inform you that I am unable to provide you with the information you have requested, as it would prove too costly to do so within the context of the fee regulations.

As you may be aware the current cost threshold is £600 and I estimate that it would cost well in excess of this amount to process your request.

As such, and in terms of Section 16(4) of the Freedom of Information (Scotland) Act 2002 where Section 12(1) of the Act (Excessive Cost of Compliance) has been applied, this represents a refusal notice for the information sought.

By way of explanation, there are 212 recorded hate incidents with a transgender hate concern marker. However, as there is no crime attached to the incident there is no straightforward method to extract the data required. In order to provide you with the information you require a manual assessment of each of the reports would need to be undertaken, then summaries of each report would need to be created. A conservative estimate is that it would take approximately 15 minutes per record which equates to 53 hours of work.

Police Scotland have assessed that the £600 cost limit within the Act equates to 40 hours of work and so this part of your request would breach the cost threshold.

However to be of assistance I have provided the recorded hate incidents with a transgender concern marker broken down by year. I would ask you to note the caveats provided below the table.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
