FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

I would like to know how many times police officers have been in attendance at Victoria Park Caravan Site, Selkirk during the last two years, i.e. from 1st March 2020 until 28th February 2022.

Please find the requested figures below:

1st March 2020 – 31st December 2020 – 39
1st January 2021 – 31st December 2021 – 23
1st February 2022 – 28th February 2022 - 3

I would ask you to note the following caveats:

- All statistics are provisional and should be treated as management information. All data have been extracted from Police Scotland internal systems and are correct as at 22nd March 2022.
- The data was extracted from the Storm Unity Database using the incident's raised date.
- Out of Force incidents and error incidents have been removed.
- The Grid East and Grid North attributed to the Storm Incident were plotted on an ArcGIS Map. Incidents located at Victoria Park Caravan Site, Selkirk were then selected. Please note, the Grid East and Grid North relates to where Police Officers are directed to attend
- A keyword search was also carried out on the locus line, and relevant records were selected.
- Please note, each record would need to be read to confirm the circumstances, and if Police Officers attended the location.
- Please note, Storm Incidents where the 'At Scene' variable is populated with a date stamp, having been selected as those records where at least one Police Unit attended the incident.

If you are dissatisfied with the way in which Police Scotland has dealt with your request, you are entitled, in the first instance, to request a review of our actions and decisions.

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to foi@scotland.pnn.police.uk or by post to Information Management (Disclosure), Police Scotland, Clyde Gateway, 2 French Street, Dalmarnock, G40 4EH.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
