## FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

Recently we have sadly had a fair number of fatal road crashes, on the A9 in particular, with a high number coming over the summer months.

Seeking statistics on the number of fatal accidents recorded across the A9 between Inverness and Perth, by month, for each of the past five years. If possible and the data can be driven down to show more specific locations, this would be welcomed.

On the 12th June 2019, CRaSH was implemented within D Division. On the 3rd July 2019, CRaSH was implemented across the other Police Divisions within Police Scotland. CRaSH replaced the existing procedures for recording Road Traffic Collisions.

The identified records have then been plotted using an ArcGIS Map (using the Grid East and Grid North recorded on the Road Traffic Collision Report). Road Traffic Collisions between Perth and Inverness on the A9 have then been selected.

If you are dissatisfied with the way in which Police Scotland has dealt with your request, you are entitled, in the first instance, to request a review of our actions and decisions.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision.
