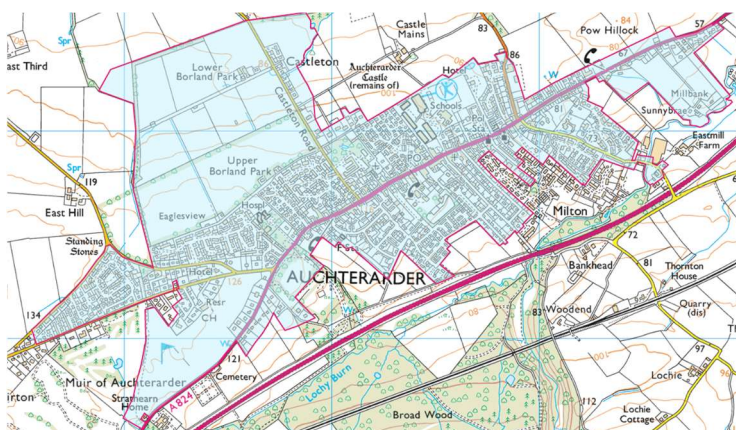
## FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

### How many traffic offences have been recorded in Auchterarder in the last 12 months?

In response to your request, please find below the recorded and detected group 7 (road traffic) crime data for the period 1 December 2021 to 30 November 2022 for beat area W66 as detailed on the map below (area within red outline).

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
