## FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

### All Road Traffic collisions, last 20 years – B930 Percival Road, Leven, Buckhaven Fife

In response to your request, I can provide the tables below which detail Road Traffic Collisions and Road Traffic Collision Casualties for the area of Percival Road (B930) located between the A915 and A955, for the period 01 January 2006 - 30 November 2021 broken by calendar year.

Information for the period prior to 2006 is *not held* by Police Scotland and section 17 of the Act therefore applies.

Similarly, where a calendar year is not listed, that is because there were 0 RTCs that year.

Please note that a reportable collision is defined under Section 170 of the Road Traffic Act 1988 and describes the legal responsibility on those drivers involved to report the matter to the police. Where those involved exchange personal details, there is no legal requirement to report a collision to the police and this applies particularly to non-injury collisions. As such, there may have been other collisions within the location of your request, which were not reported to Police Scotland, nor which required a collision report to be created, and will therefore not be included within the statistics.

Please also be advised that the number of casualties may vary from the number of collisions, as each collision may have multiple casualties.

If you are dissatisfied with the way in which Police Scotland has dealt with your request, you are entitled, in the first instance, to request a review of our actions and decisions.

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to [foi@scotland.pnn.police.uk](mailto:foi@scotland.pnn.police.uk) or by post to Information Management (Disclosure), Police Scotland, Clyde Gateway, 2 French Street, Dalmarnock, G40 4EH.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
