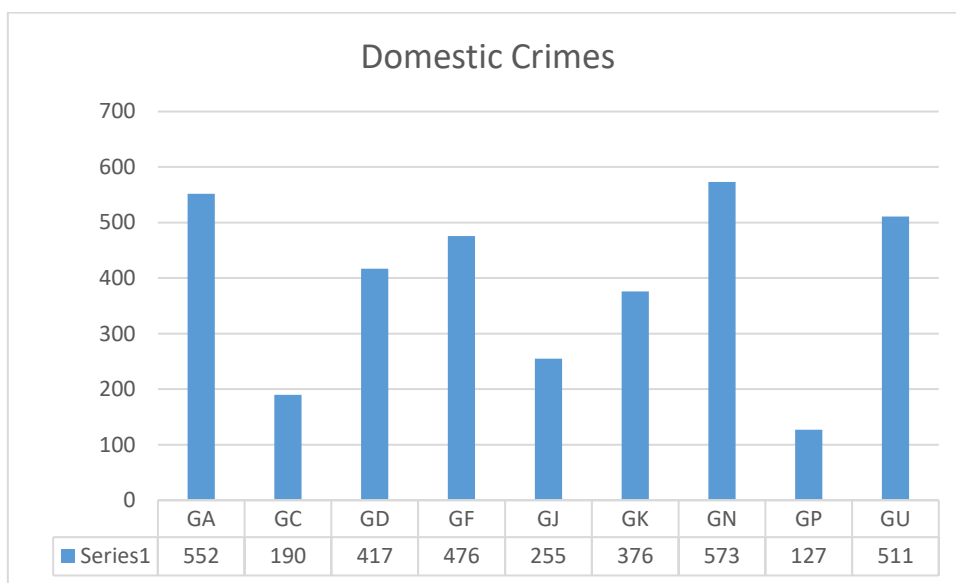

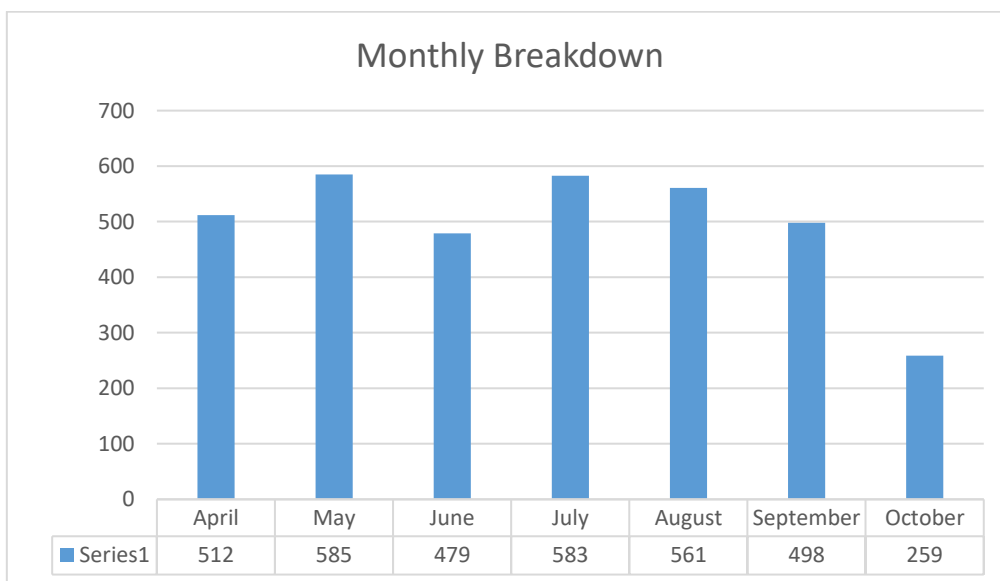
Domestic Crime Breakdown

From 1st April to 20th October there were a total of 2292 crime reports that were classed as 'Domestic'. These crime reports accounted for a total of 3477 crimes/offences being recorded. There were also a total of 244 historic crimes reported which fell into the date range (to date) which have not been included in the analysis.

The following chart shows a breakdown by Sub Division of domestic crimes/offences:-



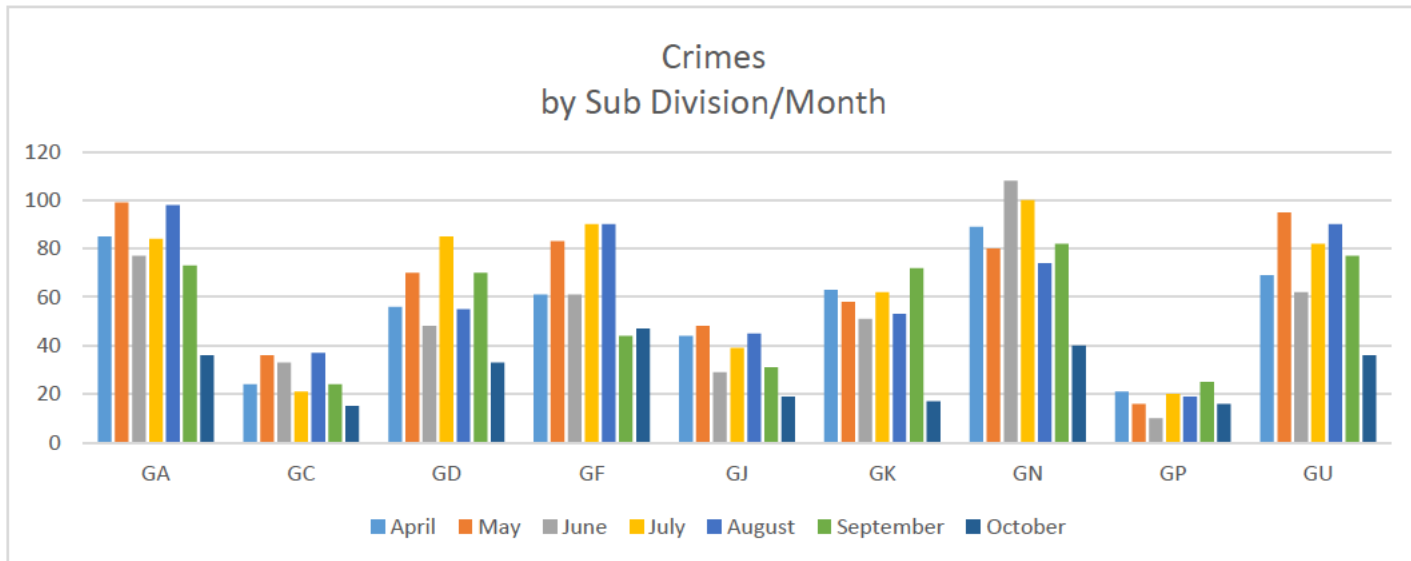
GN (Glasgow North East) and GA (Glasgow South West) Sub Divisions had the highest occurrence of domestic crimes/offences recorded accounting for 32% of the total.



May and July were the most prevalent months for 'Domestic' crimes/offences to be reported. There was an 11% decrease in September in comparison to August.

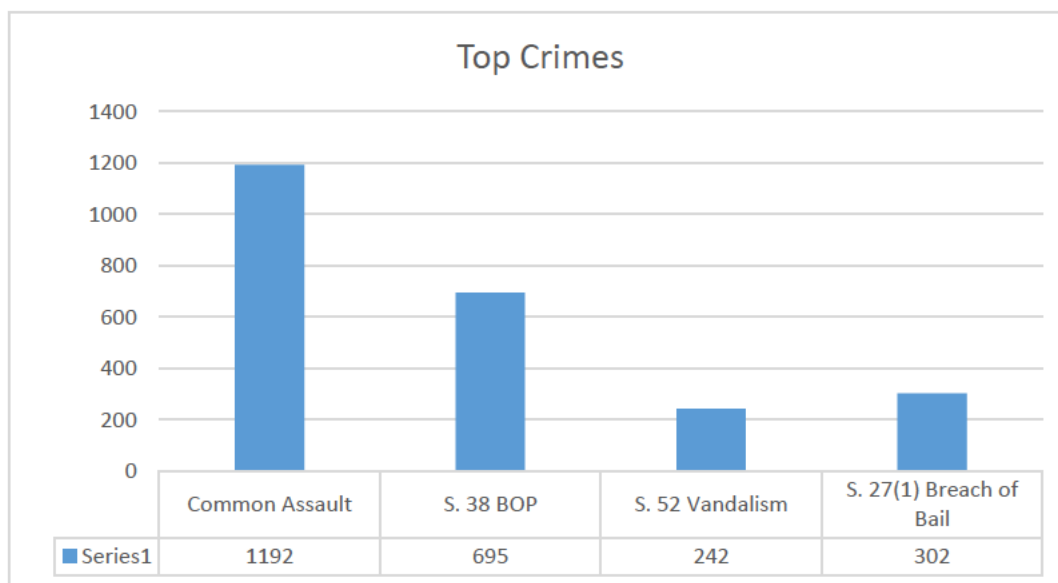

The chart below shows the breakdown by Sub Division and month of 'Domestic' crimes/offences reported during the period of analysis. As previously stated GN and GA Sub Divisions were the most problematic.



The level of crimes/offences peaked to their highest level within GN (Glasgow North East) Sub Division during June and July with 108 and 100 reported respectively. Within GA (Glasgow South West) May and August were the most problematic with 99 and 98 reported respectively. The Sub Divisions that reported an increase between August and September were GD (Glasgow South East), GK (Glasgow East), GN (Glasgow East) and GP (Glasgow City Centre). Within GF (Glasgow North) the level of crimes in October to date are higher than the month of September.

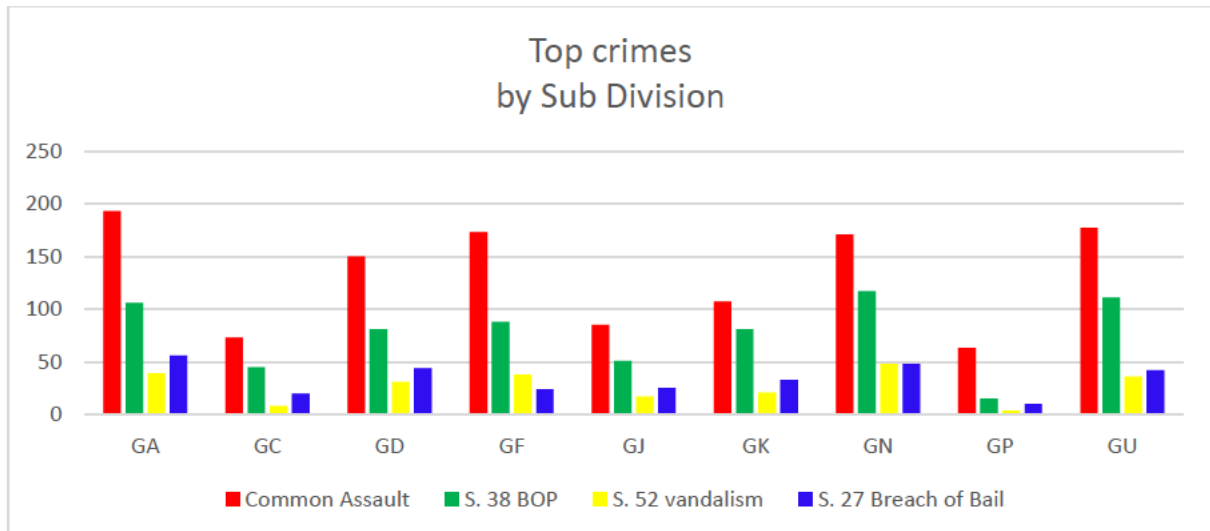
The chart below shows the four most prevalent types of 'Domestic' crime/offences reported during the period of analysis. Common Assaults accounted for 34% of the total and peaked to the highest level in August. There was a 22% decrease during September (n=159).



The following chart shows a breakdown of the top four crimes/offences by Sub Division. Common Assault was the most prevalent throughout each of the Sub Divisional areas.

GA Sub Division

This Sub Division had the highest number of Common Assaults reported in comparison with all other Sub Divisions. There were a total of 193 which reached their highest peak during May (n=36) and August (n=35). The level of assaults decreased during September (n=25). S. 38 BOP offences peaked during August (n=22) and decreased during September. October to date there were 7 reported. Vandalism offences were highest during April, May and July thereafter decreased. S. 27(1)(b) Breach of Bail offences fluctuated between 6 and 10 throughout the period with September showing the highest occurrence.

GC Sub Division

There were a total of 73 Common Assaults reported which peaked in June (n=16). The level of assaults decreased between August and September from 13 to 8. S. 38 BOP offences were highest during August. Vandalism figures for this Sub Division were low with the highest number of 3 reported in May. There were a total of 20 S. 27(1)(b) Breach of Bail offences committed the fewest committed in April and September with an increase in October to date (n=4).

GD Sub Division

There were a total of 150 Common Assaults reported which peaked in May and July with 30 and 31 crimes respectively. There was a slight increase between August and September (19 to 22 crimes). S. 38 BOP offences were most prevalent in April and July both with 16 offences reported. These offences increased between August and September (9 to 14 offences). There were a total of 31 vandalisms with similar levels throughout. S. 27(1)(b) Breach of Bail offences were most prevalent in May, July and October to date. May showed the highest occurrence of offences (n=10).

GF Sub Division

This Sub Division had the second highest number of Common Assaults reported with a total of 173. July and August were the most prevalent with 31 and 32 crimes respectively. The level decreased between August and September down from 32 to 21 crimes. S. 38 BOP offences peaked to the highest level in August (n=22) and decreased in September (n=6) to the lowest level. There were a total of 38 vandalisms that were most prevalent in July (n=9). S. 27(1)(b) Breach of Bail offences peaked in August (n=8) in comparison to September (n=1).

GJ Sub Division

There were a total of 85 Common Assaults reported with August being the most prevalent (n=22). The level decreased to 9 during September. June had the least with 7 assaults reported. S. 38 BOP offences were higher in May and August in comparison with other months with 11 and 10 crimes respectively. There were 17 vandalism crimes with no peak months. S. 27(1)(b) Breach of Bail offences ranged from 1 offence during August to 6 in July.

GK Sub Division

There were a total of 107 Common Assaults reported which were fairly consistent and peaked to 20 during September. October to date showed a decrease (n=6), however this is a partial month for analysis. S. 38 BOP offences were highest during April (n=17) and September (n=18) and decreased to 3 October to date. There were a total of 21 vandalisms that peaked in July (n=7). S. 27(1)(b) Breach of Bail offences fluctuated and were highest in September (n=8) and decreased during October to date.

GN Sub Division

There were a total of 171 Common Assaults reported in this Sub Division which was the third highest. These assaults peaked to the highest level in June (n=37). The level decreased in the preceding months. S. 38 BOP offences were most prevalent between May and July with 23, 20 and 22 crimes respectively. The peak month for vandalisms was June (n=9). S. 27(1)(b) Breach of Bail offences peaked in August (n=11) and decreased during September (n=7).

GP Sub Division

There were a total of 63 Common Assaults with April, August and September being the most prevalent with 12, 12 and 14 crimes respectively. S. 38 BOP offences were highest in July (n=4). There were only 4 vandalisms reported. S. 27(1)(b) Breach of Bail offences were also low with 3 reported in October to date.

GU Sub Division

There were a total of 177 Common Assaults reported which peaked to the highest level in August (n=38). There was a decrease in the level during September (n=21) and 12 reported in October to date. S. 38 BOP offences peaked during May (n=23) and were lowest in September (n=14) and 8 in October to date. There were 36 vandalisms reported with 11 recorded in September and 2 in October to date. S. 27(1)(b) offences were higher in July and September in comparison with other months with 9 in each month reported.

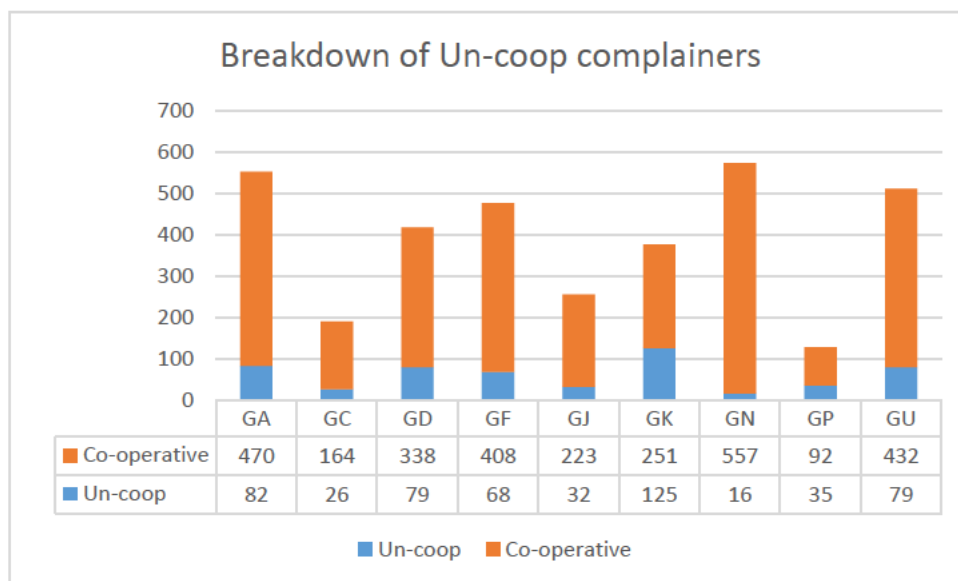

Un-cooperative Complainers

There were a total of 353 crime reports classed as having an un-cooperative complainer. These crime reports accounted for 542 crimes/offences. There were 108 crime reports with 2 or more crimes/offences reported during the period of analysis.

The following chart shows a breakdown of un-cooperative complainers by Sub Division. GK (Glasgow East) had the highest occurrence accounting for 23% (n=125) of the total.



Repeat Offenders

In relation to the top four crimes/offences previously identified ie. Common Assault, S. 38 BOP, S. 52 Vandalism and S. 27(1)(b) Breach of Bail repeat offenders were looked at. There were a total of 31 identified, 28 males and 3 females.

- One offender responsible for 4 crime reports **S38(1)(b)**
- Four offenders responsible for 3 crime reports and
- 26 offenders responsible for 2 crime reports

Common Assaults

There were a total of 693 crime reports for common assault that were detected accounting for 804 detected assaults. 89 of these crime reports had more than one assault reported.
