FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

Please can you confirm who your Head of Transport is and provide name and contact details (email address).

Can you confirm your current fleet size?

3,437

Please confirm the number of response vehicles and pool vehicles in your current fleet?

In response to this question please note that Police Scotland have a marked vehicle fleet, that is to say vehicles that have police livery or markings and an unmarked fleet that does not have any identifiable markings. Pool vehicles would be within our unmarked fleet.

Whilst we are able to release details of our marked fleet, we cannot release details of our unmarked fleet and by association pool vehicles for the reasons noted below.

In terms of Section 16 of the Freedom of Information (Scotland) Act 2002, I am refusing to provide you with the information sought. Section 16 requires Police Scotland when refusing to provide such information because it is exempt, to provide you with a notice which:

- (a) states that it holds the information,
- (b) states that it is claiming an exemption,
- (c) specifies the exemption in question and
- (d) states, if that would not be otherwise apparent, why the exemption applies.

I consider the following exemptions applicable.

Section 35 - Law enforcement

Information is exempt information if its disclosure under this Act would, or would be likely to prejudice substantially the prevention or detection of crime and the apprehension or prosecution of offenders.

Disclosure of the unmarked fleet would highlight vehicle resources and capabilities. Revealing this information would substantially weaken the effective use of vehicle resources with a corresponding risk to law enforcement and to the safety of both the public and officers.

This is a non-absolute exemption and requires the application of the public interest test.

Section 39(1) - Health, safety and the environment

The release of this information would circumvent the efficient and effective provision of law enforcement by the police service for the reasons described above. This would in turn increase the risk to the personal safety of individuals and to the safety of the police officers responding to incidents.

This is a non-absolute exemption and requires the application of the public interest test.

Public Interest Test

I recognise that public awareness would favour a disclosure as it would contribute to the public debate surrounding the overall nature of vehicle resources available for deployment by the Police.

I would, however, contend that the efficient/effective conduct of the service and public safety favours retention of the information as it cannot be in the public interest to release information that would prejudice law enforcement or which is likely to have an adverse impact upon public safety.

In relation to our marked fleet, I can confirm there are 1,669 marked vehicles in our current fleet.

Please can you confirm who is your breakdown provider (2022)?

The AA.

Can you please confirm how your vehicles are serviced e.g. whether you have your own workshops/ use council workshops?

Police Scotland vehicle workshops

Please provide the total number of workshops (and technicians) that you use including town location?

We have 9 vehicle workshops throughout Scotland and 51 vehicle technicians.

Please can you confirm your annual Spend on service, maintenance FY March 2020-April 2021)?

Please note that I have assumed by "FY March 2020-April 2021" you mean the financial year which runs from April 2020 to March 2021.

The service and maintenance cost relating to vehicles in financial year 2020/21 is £5,732,557

Please can you confirm your annual spend on damage repair (FY March 2020-April 2021)?

Please note that I have assumed by "FY March 2020-April 2021" you mean the financial year which runs from April 2020 to March 2021.

£1,557,115.72 was spent on damage repair in financial year 20/21. These costs are for repairs carried out on vehicles damaged between 1st April 2020 and 31st March 2021 rather than a total for any damage invoices paid during the same time period.

If you are dissatisfied with the way in which Police Scotland has dealt with your request, you are entitled, in the first instance, to request a review of our actions and decisions.

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to foi@scotland.police.uk or by post to Information Management (Disclosure), Police Scotland, Clyde Gateway, 2 French Street, Dalmarnock, G40 4EH.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
