FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

Can you tell me how many cases of child neglect or abuse have been the subject of child protection meetings in 2019,2020 and 2021.

In response to this question, I regret to inform you that I am unable to provide you with the information you have requested, as it would prove too costly to do so within the context of the fee regulations.

As you may be aware the current cost threshold is £600 and I estimate that it would cost well in excess of this amount to process your request.

As such, and in terms of Section 16(4) of the Freedom of Information (Scotland) Act 2002 where Section 12(1) of the Act (Excessive Cost of Compliance) has been applied, this represents a refusal notice for the information sought.

By way of explanation, the only way to provide an accurate response to your request would be to read the detail of every crime report/ interim Vulnerable Persons Database entry to establish whether a child was discussed at a meeting and, if so, on how many occasions. Given the volume of reports, this is an exercise which I estimate would far exceed the cost limit set out in the Fees Regulations.

Did any child die over those years linked to abuse or neglect? Where did this happen and how old was the child.

In response to this question, I can again provide that Section 16(4) of the Freedom of Information (Scotland) Act 2002 where Section 12(1) of the Act (Excessive Cost of Compliance) has been applied, this represents a refusal notice for the information sought.

To explain, your request in its current format would include crime reports i.e. murder etc. but also sudden death reports that have been reported to the Crown Office and Procurator Fiscal Service. Police Scotland are unable to search either based on "linked to abuse or neglect".

We may be able to provide crime data i.e. murder with a child victim and cruel & unnatural treatment of children. Should these stats be of interest to you please submit a new request.

If you are dissatisfied with the way in which Police Scotland has dealt with your request, you are entitled, in the first instance, to request a review of our actions and decisions.

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to foi@scotland.police.uk or by post to Information Management (Disclosure), Police Scotland, Clyde Gateway, 2 French Street, Dalrnarnock, G40 4EH.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
