FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

I am looking for Shetland Islands figures from the period 2011 until 2021, as follows;

- Sexual assault against a child aged 13-15
- Sexual assault against a child under 13
- Other sexually coercive conduct against a child aged 13-15
- Other sexually coercive conduct against a child under 13
- Other sexual crimes involving 13-15-year-old children

In response to your request I can provide the recorded crimes captured by the terms of the request (i.e. by stats class codes) for the period 1st January 2011 – 31st December 2021.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision.
